## Genesee Mine Rescue Team

## The Falcons Return



A pair of Peregrine Falcons returned to the Genesee Generating Station on Sunday April 8, 2012. They were spotted creating a "scrape" in the nest box which is a preparation sign of egg laying/nesting. As of May 9, 2012 four eggs have been laid.

Falcons have been nesting and raising young at Genesee for several years. There is a nesting box on the midpoint platform on the outside of the G3 stack that the birds call home from early April to late July.

## **Local Students Learn About Cougars**





Capital Power was pleased to present talks by a cougar expert to students from both Warburg School and Mother Earth School on March 23, 2012. These talks were conducted by



wildlife researcher Kyle Knopff, PhD, who was the researcher who managed the cougar tracking program at Genesee. Information was presented on cougars' traits, their habitat, and history; he also provided safety tips to the students. Kyle shared information on the two cougars, Capi and Bill, who were collared between 2009 and 2010 in the Genesee area. Both Capi and Bill were estimated to be 3-4 years of age and at time of capture they weighed 140 lbs. Capi measured 210 cm from nose to the end of his tail. Kyle noted that the tips of Capi's ears had been frozen off. Bill was 214 cm long (nose to tail tip), and he had a scar on his left hind leg. Both cats were in good condition when collared. The study is now completed and a full report on the study, created by Kyle and his team, will be made available later this year.

# REPORT WILDLIFE -WILDLIFE MONITORING



Capital Power continues the Wildlife Monitoring program on the main thoroughfares around the Genesee Station to determine areas that show high frequency for wildlifevehicle collisions.

Capital Power shares this report with Leduc County and it is incorporated into the bio-monitoring program that is ongoing in the Genesee area. Reported incidents are used as a basis to improve visibility or signage in those areas considered most frequented by wildlife.

# Genesee Connection – Stakeholder Feedback

A reader of the Genesee Connection asked us to clarify a table published in the March 2012 Genesee Connection on Page two. Here is further information on the terms used in the table and the table that was published:

Genesee Mine Reclamation Summary 2011 Year End		
Category	Land Area (ha)*	% of Total
Fully Reclaimed	686	26.6%
Reclamation in Progress	303	11.7%
Required for Safe & Efficient Mining	1,593	61.7%
Total	2,582	100.0%

- Fully Reclaimed: this describes previously mined land that has had topsoil placed on it and is back in full agricultural production. It may also include land that has been planted to trees for reforestation.
- Reclamation in Progress: this relates to land where final surface contours after are being developed following mining operations. As part of this process, one meter of suitable subsoil placed on the surface, followed by 20 cm of topsoil. These lands are not completed enough for agricultural use.
- Required for Safe and Efficient Mining: this relates to land in the actual area of the mining operation e.g. the open pit, mine haul roads, topsoil storage sites, mine buildings etc.

In terms of timing, pre-mining activities (disturbance of the land) started in 1988, actual mining began in 1989. Reclamation of the mined areas started in 1990 and continues now as it is an ongoing activity.

#### **Genesee Station Environmental Performance**

The following graphs show the most recent environmental performance results:

- Ambient air quality as measured by the Genesee ambient air monitoring trailer;
- Stack emissions for stack one (for generating units 1 and 2);
- Stack emissions for stack two (for generating unit 3).

Measurements are compared to guidelines and approval limits set by Alberta Environment. Genesee continues to operate below maximum levels set for ambient air quality and stack approval limits.

'Sulphur Dioxide (SO<sub>2</sub>): a strong smelling, colourless gas that is formed by the combustion of fossil fuels. In high concentrations, SO, is known to be harmful to vegetation and human health. SO, is soluble in water and excessive levels can lead to sulfuric acid deposition or

Nitrogen Oxides (NO<sub>x</sub>): the term used to describe NO (nitrogen oxide), NO<sub>2</sub> (nitrogen dioxide) and other nitrogen oxides. The major sources of man-made NO are hightemperature combustion processes, such as those occurring in automobiles and power plants. When concentration is high, NO, is of concern because it contributes to ground-level ozone or smog. Genesee 3 approval limits are based on a 720 hour rolling average.

Note: All results are converted to reference standard conditions so as to be comparable to other coal fired plants in Alberta and elsewhere, and are dry concentrations corrected to 50% excess air; ppm: parts per million. An example of the quantity of Sulfur Dioxide and Nitrogen Oxides measured at ambient air sites in parts per million would be equal to approximately 1/100th of a grain of salt per breath of air. G3 has separate approval limits from G1 and G2 for its stack emissions. G3 approval limits are in terms of a mass emission rate (i.e. tonnes per hour). To be consistent for all units, we have shown G1 and G2 emissions and limits in tonnes/hour as well.
