## Application for the Genesee generating station units 4 and 5 in the Genesee area

Capital Power Generation Services Inc. filed a facility application to construct and operate two natural gas-fired generation units, with a total capacity of 1,050-megawatts (MW), on a brownfield site adjacent the existing Genesee generating station located approximately 30 kilometres southwest of Stony Plain, Alberta. The Genesee generating station currently includes units 1 to 3 and the two new units, if approved, would be designated as Genesee generating station units 4 and 5.

Anyone who wishes to express objections to, concerns about, or support for the application, must make a written submission to the Alberta Utilities Commission on or before **March 28, 2014**, clearly identifying **Proceeding ID No. 2996** on the submission.

### Information about the application:

#### Capital Power Facility Application No. 1610202

In accordance with Section 11 of the *Hydro and Electric Energy Act*, Capital Power filed an application with the AUC on December 20, 2013, requesting approval to construct and operate the Genesee generating station units 4 and 5. The project will use natural gas combined-cycle technology and each unit consists of a single natural gas turbine paired with a heat recovery steam generator and a single steam turbine. The project will be located in the southeast quarter of Section 25, Township 50, Range 3, west of the Fifth Meridian.

**AUC decision-making process:**

The AUC is reviewing the application and will advise when it has been deemed complete and will review submissions received. Those who have made submissions, who have been determined by the Commission to have rights that may be directly and adversely affected by a decision on this application, will be considered to have standing. If no submissions are received, or if submissions are received from persons without standing, the AUC may make a decision on the application without further notice or without a public hearing. Alternatively, the Commission will hold a public hearing if it receives an objection from a person with standing and further details will be provided in a notice of hearing.
